Security Management related procedures regarding International Conference on Protection of Rights of the Migrant Workers

National Human Rights Commission, Nepal carried out a discussion meeting .The discussion took place today with 3 district administration offices and head of security wings in Kathmandu valley regarding organizing security for the participants and other related issues in conjunction to International Conference on Protection of Rights of the Migrant workers.
